WHL/WHL Group: Woolworths Holdings Limited, a southern-hemisphere retail Group that has been listed on the Johannesburg Stock Exchange (JSE) since 1997. It is one of the top JSE-listed companies. The Group trades through three operating subsidiaries, including Woolworths Proprietary Limited (Woolworths or WSA), Country Road Group Proprietary Limited (Country Road Group or CRG), and David Jones Proprietary Limited (David Jones or DJ). Woolworths Financial Services Proprietary Limited (WFS) is a joint venture with Absa bank, which holds the controlling interest in the joint venture

WIETA: Wine and Agricultural Ethical Trade Association, an association that drives a sustainable ethical trade programme for the South African wine industry and aligned sectors. WIETA is also a globally recognised ethical auditing body registered with the Global Social Compliance Programme (GSCP)

Woolworths/Woolworths SA/WSA: Woolworths Proprietary Limited, a trading subsidiary of Woolworths Holdings Limited

WWF-SA: World Wide Fund for Nature South Africa, a non-governmental organisation that is dedicated to protecting South Africa's natural heritage. This includes plant and animal species and people

YES: Youth Employment Service, an organisation aimed at benefiting one million South African youth, launched by the President of the Republic of South Africa in March 2018

Allyship: A term used in contemporary social justice activism to describe efforts by groups of people to advance the interests of marginalised groups, both in society at large and within particular social contexts, such as universities or workplaces

Anker Methodology: A methodology to measure a decent but basic standard of living in different countries, and how much workers need to earn to support themselves and their families. This information allows researchers to estimate comparable living wages around the world, and determine gaps between living wages and prevailing wages, even in countries with limited secondary data

Aspartame: Artificial sweetener

Aware.org/AWARE: A non-profit organisation registered with the South African Department of Social Development that focuses on preventing the negative consequences of alcohol abuse

Azo dye: Synthetic dye

B

Better Cotton: A non-profit organisation that promotes better standards in cotton farming and practices

Bluesign[®]: A certification system for the elimination of harmful substances at each step of the textile supply chain, and use of approved chemicals, processes, materials, and products that are safe for the environment, workers, and customers

Bokashi: Fermented organic matter used in food composting

Botanicca: Head office of Country Road Group and David Jones

Canopy: A non-profit environmental organisation dedicated to protecting the world's forests, species, and climate

Carbon dioxide equivalent (CO₂e): A measure used to compare the emissions from various types of greenhouse gases (GHG) based on their global warming potential (GWP)

Carbon footprint: The total amount of greenhouse gas emissions released into the atmosphere as a result of the activities of a particular individual, organisation or community

CEO Water Mandate: A UN Global Compact initiative that mobilises business leaders on water, sanitation, and the Sustainable Development Goals

Cocoa Life: A sustainable cocoa sourcing programme

Commodity: A raw material or primary agricultural product that can be bought and sold, for example, cotton or palm oil Context-based water target: A specific, time-bound objective that sets the desired outcome to include both a component that speaks to the company's water performance and a component that speaks to the water basin's conditions

Cyclamate: Synthetic sweetener

D

Detox: A programme championed by Greenpeace for the removal of hazardous chemicals from the production of clothing garments

Ε

Energy productivity: An indicator of the amount of economic output that is derived from each unit of energy consumed ETI Base Code: An internationally recognised code of labour practice, founded on the conventions of the International Labour Organization (ILO)

Factories of the future programme: A Woolworths supplier self-assessment, covering sustainability management, water, energy, climate change, waste, food waste, human rights, employee wellbeing, packaging, transformation, and responsible sourcing. Based on the score, suppliers are ranked according to their performance with a Red, Bronze, Silver or Gold rating

Fairtrade: A system of certification that aims to ensure a set of standards are met in the production and supply of a product or ingredient. For farmers and workers, Fairtrade means workers' rights, safer working conditions, and fairer pay

Farming for the Future: A scientific, data-based approach to farming, developed by Woolworths, that aims to manage a farm as part of its wider ecosystem. The programme comprises various modules for which data points are measured at a farm level, including data related to soil health, water-use efficiency, crop protection, energy use, irrigation efficiency, and leakages and wastewater management. This data is then used by farmers to make decisions that will assist them in making continual improvements over time, with the aim of enabling them to produce more food with fewer natural resources. The programme is geared towards improving the farm's resilience, yield, and profitability while at the same time enhancing its ecosystem's capacity over time

Fashion Transparency Index: The Fashion Transparency Index ranks 250 of the world's largest fashion brands and retailers according to how much they disclose about their social and environmental policies, practices, and impact

Fishing for the Future: Woolworths' approach to procuring responsibly sourced seafood as part of its Good Business Journey

FoodForward SA: A non-profit organisation that recovers edible surplus food at various stages of the food value chain, and redistributes it to communities in need across the country, thereby improving access to food and reducing food waste to landfill

Fur: Any fur from animals bred and farmed purely for their skins, including mink, sable, chinchilla, fox, muskrat, racoon dog, rabbit, astrakhan, and karakul. It excludes by-products of the meat industry, such as shearling and sheepskin

G

GHG Protocol Corporate Accounting and Reporting Standard: A standard that provides requirements and guidance for companies and other organisations preparing a GHG (greenhouse gas) emissions inventory (carbon footprint)

Global Living Wage Coalition: The Global Living Wage Coalition (GLWC) brings together Fairtrade International, GoodWeave International, the Rainforest Alliance, and Social Accountability International (SAI), in partnership with the ISEAL Alliance and international living wage experts Dr Richard Anker and Martha Anker, with the shared mission to see continuous improvements in workers' wages in the farms, factories, and supply chains participating in their respective certification systems and beyond, and with the long-term goal for workers to be paid a living wage. The GLWC aims to develop living wage benchmark estimates in many countries based on a single definition and methodology to calculate a living wage, and as a critical step to enable industries and companies to move towards paying a living wage

Global Recycle Standard (GRS): An international, voluntary, full product standard that sets requirements for third-party certification of recycled content, chain of custody, social and environmental practices, and chemical restriction

Global Reporting Initiative (GRI) Standard: A widely adopted global standard for sustainability reporting

Global Sustainable Seafood Initiative (GSSI): A global partnership that has established a benchmark for seafood certification schemes

Green cafés programme: A sustainability programme for WCafés that sets out key goals to drive year-onyear continuous improvement in terms of the following key principles: responsible sourcing, healthy food options, packaging and food waste, ethics and people, and environmental impacts

Greenhouse gas (GHG) emissions: Emissions of gases, both natural and anthropogenic, that trap heat in the atmosphere and cause the greenhouse effect

GreenPower: A government-accredited renewable energy product offered by most electricity retailers to households and businesses in Australia

Internal green building protocol: A Woolworths specification for the design of new stores, which stipulates various eco-friendly requirements, with an internal rating of Platinum, Gold or Silver awarded depending on which requirements are met by each new store

International Labour Organization (ILO) conventions: International labour standards and legal instruments drawn up by the ILO's constituents (governments, employers, and workers), setting out basic principles and rights at work

International Pole and Line Foundation (IPNLF): A charity that works to develop, support, and promote one-by-one tuna fisheries. One-by-one is a collective term that includes pole-and-line, handline, and troll line fishing methods, in which fish are caught one at a time

Ipsos: A multinational market research and consulting firm

Key commodities: Palm oil, cocoa, coffee, sugar, soya, cotton, fish and seafood, man-made cellulose fibres, leather, timber, and synthetics

Kinder to Sows pork: Pork sourced from farms that no longer use sow stalls to restrain pregnant sows for prolonged periods, reducing the time adult sows spend in gestation crates from 16 weeks to under one week

Living wage: The remuneration received for a standard workweek by a worker in a particular place, which is sufficient to afford a decent standard of living for the worker and their family. Elements of a decent standard of living include food, water, housing, education, healthcare, transportation, clothing, and other essential needs, including provision for unexpected events

Man-made cellulose fibres (MMCFs): Fibres derived from wood, such as viscose, rayon, lyocell, and modal

Mass balance: The purchase of 100% certified sustainable commodity equivalent to the volume of commodity needed for a certain product (range). The certified commodity physically enters the supply chain but is not necessarily physically separated (segregated) from non-certified commodity throughout the whole chain. This process minimises logistical barriers related to sustainable commodity uptake, and means that certified farmers still fully benefit from the better conditions

Modern slavery: Institutional slavery such as trafficking in persons, slavery, servitude, forced labour, forced marriage, debt bondage, deceptive recruiting for labour or services, and child labour

Mulesing: A painful surgical procedure involving the removal of strips of wool-bearing skin from around the breech of a sheep to prevent the parasitic infection known as flystrike

Oeko-Tex® Standard 100: Oeko-Tex® is a worldwide association of independent institutes for product safety and sustainable production in the textile industry. Standard 100 by Oeko-Tex® is used for the testing and certification of textile products

OzHarvest: An Australian food rescue organisation, which collects quality excess food from commercial outlets and delivers it directly to more than 1 300 charities

Plant-based: Products that encompass a spectrum of eating patterns focusing on eating whole plants, including vegetables, fruit, whole grains, nuts, seeds, and legumes, and eating fewer or no animal products

Poly bag: A plastic bag

Primary supplier: A supplier that supplies Woolworths directly

Private label products: Goods that are manufactured or produced for, and sold under, the name of one of Woolworths Holdings Limited's trading subsidiaries

R

Rainforest Alliance: An international non-profit organisation working at the intersection of business, agriculture, and forests to make responsible business the new normal

Ratio packs: Package of a single style garment, but in various sizes

Recycled Claim Standard (RCS): An international, voluntary standard that sets requirements for third-party certification of recycled input and chain of custody

Renewable energy certificate: A market-based instrument that certifies the bearer owns one megawatt hour (MWh) of electricity generated from a renewable energy resource

Responsible sourcing: The procurement of products as well as raw material commodities from sources, be they farms or factories, that apply environmental and social best practice and are accredited to applicable best-in-class third-party standards

Responsible Wool Standard: A standard which certifies that sheep farmers meet rigorous animal welfare and land management requirements

Reverse osmosis: A water-purification process that uses a partially permeable membrane to remove ions, unwanted molecules, and larger particles from drinking water

Reverse vending machine: A machine that customers can use to dispose of their recyclables

S

Saccharin: Artificial sweetener

Science-based targets: Reduction targets adopted by companies to reduce greenhouse gas (GHG) emissions in line with the latest climate science in order to meet the goals of the Paris Agreement – to limit global warming to well below 1.5 °C above pre-industrial levels

Scope 1 emissions: Greenhouse gas emissions from sources that are owned or controlled by the reporting company

Scope 2 emissions: Greenhouse gas emissions from the generation of electricity, heat, or steam that has been purchased by the reporting company

Scope 3 emissions: All other indirect greenhouse gas emissions that occur in a company's value chain

Secondary supplier: An indirect supplier to Woolworths, i.e. a supplier who supplies to a Woolworths supplier

SEDEX: A not-for-profit membership organisation for businesses committed to the continuous improvement of ethical performance within their supply chains

SEDEX Members Ethical Trade Audit (SMETA): An ethical audit format that reports on SEDEX's four pillars of labour, health and safety, environment, and business ethics

South African Plastics Pact: A collaborative initiative that brings together key stakeholders from the South African plastics value chain, including businesses, the South African government, and non-governmental organisations, to tackle plastic waste and pollution at its source

Sustainability attribute: A product characteristic that contributes to minimising the social and/or environmental impacts of a Woolworths Holdings Limited private label product at one or more stages of the value chain

Sustainable farming: Farming and fishing practices that promote a sustainable food system, in which soil health is improved, water supply is protected, biodiversity is restored, rural livelihoods are supported, fish stocks are protected, good animal welfare is promoted, and, ultimately, where sufficient food is provided to meet the needs of customers now and into the future

Sustainable fibres: Fabrics produced in a responsible way, derived from sustainable sources, and supported by good farming practices

Synthetics: Textiles made from chemicals or artificial substances rather than from natural ones, for example polyester and nylon

Tier 1 supplier: A manufacturer of finished product

Vancouver Declaration: A public promise made by companies across the globe to work towards more sustainable sourcing of forest products. It also acts as an endorsement of the Forest Stewardship Council (FSC) as the supplier of choice for certification of forest products

Vision 2025⁺: Group Good Business Journey strategy, goals, and commitments to 2025 and beyond

Visual merchandising: The practice of organising and displaying products in a retail space, using things such as floor plans, colour, lighting, displays, technology, and other elements to attract customers' attention

Void fill: Cushioning, padding or paper used to fill empty space in boxes, with the ultimate aim of protecting the box's contents during transit

W

Water resilience: The ability to resist, absorb, accommodate, and recover from water-related hazards in a timely and efficient manner

Water Resilience Coalition: An industry-driven, CEO-led coalition of the UN Global Compact's CEO Water Mandate that aims to elevate global water stress to the top of the corporate agenda, and preserve the world's freshwater resources through collective action in water-stressed basins and ambitious, quantifiable commitments

Water stewardship: Use of freshwater that is socially equitable, environmentally sustainable, and economically beneficial, achieved through a stakeholder-inclusive process that involves site- and catchment-based actions

We Mean Business Coalition: A global non-profit coalition working with the world's most influential businesses to take action on climate change

WWF-SASSI: The WWF South African Sustainable Seafood Initiative

WWF-SA's Water Balance Programme: A project that aims to protect some of South Africa's most important watersource areas through the removal of alien (invasive) vegetation
